Eligibility Age – 5 years to 13 years

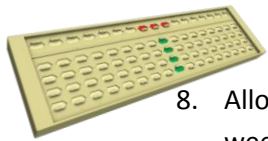
Core Benefits of Indian Abacus Program –

Looking at the special requirements of the school, Indian Abacus Program has created the model, offering Indian Abacus device, Indian Abacus Course Material and the Training for the teachers. Process of Implementation:

1. Schools interested would express their interest for the introduction of Indian Abacus Program by filling in the School Centre Application form.
2. Pay the Centre Processing Fee of Rs.2000/- plus GST.
3. Sign the MOU – the guidelines for implementation and expression of the obligations of Indian Abacus Company and the School Management, etc.
4. Nominate the Teachers of the school for the training. (2 teachers for the 1st 150 students and 1 extra teacher for every additional 150 students) No training fee.
5. Submission of Tutor Application forms for each of the nominated teachers and payment of Training fee of Rs.1000/- each - above 15 teachers.
6. Procure Initial Student Kits – matching the number of students of the class/classes paying Rs.575/- or Rs. 295/- each (one time – at the time of enrolment)
7. Payment for every level the cost of course material and the Certification - Rs.118/- per student/per level.

8. Allot & Conduct 2 or 3 periods each week (of 40 minutes each) for every class/batch to complete each week's syllabus in 4 months.
9. Home Practice – 15 minutes of per day for the student.
10. At least 2 levels per year will have to be completed.
11. Conduct Level Completion Test at the end of each level (after a minimum of 36 periods of coaching apart from the Home practice sessions). Minimum of 70% marks in the Level completion tests is essential.
12. Obtain the Level Completion Certificates from the Company for issuing to students.
13. Material Packing & Forwarding & Freight charges to be borne by the school.

Briefing regarding the administration of the program will be done to the Co-ordinator and also to the teachers who will impart training to the students. Training to the teachers will be given at the Indian Abacus Company Training centre on the scheduled dates. The school will be intimated about the dates so that the teachers could be deputed for training.

Note:

All payments towards cost of material and level based course material and certification fees have to be made upfront by the school management to the company. The names of the Students, Parent's name, Date of birth, Class studying with address and contact details have to be data-entered into the Franchise Management System software of the Company, for which user ID and password will be provided by the company. This will facilitate issue of certificates and other related communications.
